**FY 2017 CONSOLIDATED ANNUAL PERFORMANCE
AND EVALUATION REPORT (C.A.P.E.R.)**

In accordance with Title I of the National Affordable Housing Act of 1990, P.L. 101-625, the City of Martinsburg has prepared its Fiscal Year 2017 Consolidated Annual Performance and Evaluation Report (C.A.P.E.R.) for its Community Development Block Grant Program (CDBG) and the HOME Investment Partnership Program (HOME). This report describes the level of housing assistance and other community development activities designed to benefit low- and moderate-income persons and households through various federal funding programs during Fiscal Year 2017 (July 1, 2017 through June 30, 2018).

The City will hold a public hearing on Thursday, September 6, 2018 at 4:00 PM, prevailing time in the J. Oakley Seibert Council Chambers, City Hall, 232 North Queen Street, Martinsburg, WV. The Martinsburg City Hall and the J. Oakley Seibert Council Chambers are accessible to persons with physical disabilities. The purpose of the public hearing will be to obtain residents comments on the C.A.P.E.R. document. All comments will be incorporated into the final C.A.P.E.R. document.

The City of Martinsburg intends to submit the FY 2017 C.A.P.E.R. to the U.S. Department of Housing and Urban Development on or before September 28, 2018.
